

- Annual fee collected by the City of Burnaby
- Pays for City staff, building maintenance and operation

Bonsor 55+ Group Fees

- Annual fee to the society for each Bonsor 55+ group you join
- As a non-profit run by volunteers the Society has limited sources of income (dances, coffee bar), but numerous expenses including:
 - o Insurance commercial and general liability
 - Approximately \$6,300 for 2023 (dependent on total membership)
 - Copier lease and supplies
 - Approximately \$1,100 per year
 - o Lounge upkeep and office supplies
 - Budgeted for \$2,500 for 2023 due to upholstery cleaning, repair, and furniture replacement
 - o Events
 - Christmas dinner dance
 - Volunteer luncheon
 - Group leaders gathering
 - Seniors games sponsorship
 - Estimated at \$10,000 for 2023
