a) We have over \$150,000 in savings - the interest rate is about 1.3%. Alternative would be to invest in term deposits of 4% or higher; term deposits need at least a 6-month commitment. In November we anticipated an imminent bus purchase and moved the \$100,000 term deposit to savings. If we now anticipate a later purchase, we should reconsider investing the funds in term deposits.
